## Visit of Smt. Harsimrat Kaur Badal, Hon'ble Minister of Food Processing Industries, Government of India to the UAE





A high-level delegation led by Smt. Harsimrat Kaur Badal, Hon'ble Minister of Food Processing Industries, Government of India visited UAE from 16 to 18<sup>th</sup> February 2020 to participate in 25<sup>th</sup> edition of Gulfood 2020. Smt. Harsimrat Kaur Badal inaugurated the Indian pavilion at Gulfood on 16<sup>th</sup> February 2020 in Dubai in the presence of H.E. Pavan Kapoor, Indian Ambassador to the UAE; Mr Vipul, Consul General of India in Dubai; and a number of senior officials.

The Indian Pavilion was spread across 4,500 square meters and over 300 Indian companies showcased a diverse array of food products, including pulses, grains & cereals; beverages; meat & poultry; dairy; health & wellness brands; and fats & oils, amongst others.

The Government of India was represented at Gulfood 2020 by Agricultural and Processed Food Products Export Development Authority (APEDA), Tea Board India, Coffee Board India, Coconut Board of India & Cashew Export Promotion Council.

Hon'ble Minister toured the fair and held one-on-one meetings with the UAE companies involved in agri-food business and major investors including Sharaf Group, Lulu Group, Iffco, Al Maya, and Al Ghurair Group. Based on the discussions, it was proposed to explore the possibility of setting up a fund for providing marketing support to launch Indian products in the UAE supermarkets.

During discussions with the UAE India Food security corridor project representative, Hon'ble Minister proposed that existing MOFPI supported infra may be utilised to give a head start to the project. Smt. Harsimrat Kaur Badal emphasized on fast tracking the project and mentioned that all necessary support for grounding the project will be provided by the Ministry through Invest India.









Smt. Badal also highlighted the unique opportunities offered by India along with supportive policy environment and urged investors from across the globe and the UAE to avail benefits of the schemes of Indian Ministry of Processing Industries to set up new enterprises in India.

On the sidelines of the event, Smt. Harsimrat Kaur Badal had a bilateral meeting with H.E. Mariam Bint Mohammed Saeed Hareb Almheiri, UAE Cabinet Member and Minister of State for Food Security. During the meeting, both sides expressed satisfaction at the existing bilateral cooperation in the field of food security, with India being one of the largest food exporters to the UAE. Both dignitaries also deliberated upon ways and means to further increase cooperation and collaboration in the sector between the two nations.

In this context, Smt. Badal and H.E. Almheiri discussed UAE investments in food corridors in India in accordance with the vision given by the senior leadership of the two countries. They both mentioned that the two sides could also exchange information in new areas such as Saline Water Agriculture. Smt. Harsimrat Kaur Badal highlighted the enormous potential for investments in the food processing sector in India. The UAE side stays positive on opportunities for investing in various areas of food processing in India such as cold chains, food parks, contract farming and logistics.

During the visit, Smt. Harsimrat Kaur Badal had also addressed a business roundtable on "Opportunities in the Food Processing sector in India" organized by Consulate General of India, Dubai in association with PIOCCI, UAE. Over 50 prominent business groups, traders and investors had participated in the roundtable.

In her address, Hon'ble Minister apprised the participants about the steps taken by Indian Government for ease of doing business and the investor friendly policies in food processing sector. She invited business groups to invest in food parks wherein, Government of India gives support of upto Rs 50 crore. Smt. Badal highlighted the Operation Green scheme of Government of India for integrated development of tomato, onion and potato. She also emphasized that India can become a major player in organic food, especially the states in the North East.

The participants at the business roundtable appreciated the various steps taken by Indian Government for promoting trade and investment. The discussions also resulted in some valuable suggestions such as on single window clearances for investments, standardization of certificates for food exports from India, recognition of organic products of India, support for SMEs in identifying new markets and marketing of Indian products.

The business roundtable was also attended and addressed by H.E. Pavan Kapoor, Indian Ambassador to the UAE and Mr Vipul, Consul General of India in Dubai.

#### Etihad Airways celebrates 15 years of flying to India





**February 2020** - Etihad Airways, the national airline of the UAE and member company of UAE-India Business Council (UIBC) hosted an event for frequent flyers, key trade, Government and media officials on the occasion of celebrating 15 years of flying to India.

The airline began its operations in India in September 2004 and it has grown to become its second largest market after the UAE, carrying over 18 million passengers to and from the country.

Mumbai was the first route in the country to be served by Etihad and today the city ranks highest in terms of total passengers the airline has carried over the years, with the number exceeding 3.5 million. Owing to passenger demand on this route, the airline introduced a fourth daily service to Mumbai last year.

The cities of Delhi and Cochin rank second and third, with the airline carrying over 3.2 million and 2.3 million passengers on these routes respectively over the years. Etihad has also added a fourth daily frequency on its Delhi - Abu Dhabi route, to meet high demand.

As a result of its optimised schedule of non-stop flights between the United Arab Emirates and India, appealing to greater numbers of point-to-point business and leisure passengers, Abu Dhabi is now the most popular destination for Indian travellers on the Etihad network. Today, Etihad operates 161 return flights per week between Abu Dhabi and 10 key Indian gateways of Ahmedabad, Bengaluru, Chennai, Cochin, Delhi, Hyderabad, Kolkata, Kozhikode, Mumbai and Thiruvananthapuram, connecting each of these gateways to international destinations throughout the Middle East, Europe, North America, and Africa.

At the event, Mr Danny Barranger, Senior Vice President Global Sales, Etihad Airways shared, "Etihad Airways remains committed to its largest and busiest market, India. The UAE and India have shared strong commercial, cultural and historic relations and we will continue to honour these excellent trade and tourism ties through closer partnership with our friends in the Indian travel trade. We are proud that today Etihad Airways serves more destinations in India than any other country across its network, truly supporting the growth of air travel to and from the country."

Marking Etihad's 15 years of flying to India, Ms Neerja Bhatia, Vice President - Indian Subcontinent, Etihad Airways apprised that India plays a crucial role in Etihad Airways' growth strategy, contributing significantly to the airline's global operations and we are honoured to support demand in one of the fastest growing aviation markets in the world.
