Participation of UAE Delegation in Vibrant Gujarat Global Summit 2019






H.E. Dr. Thani bin Ahmed Al Zeyoudi, UAE Minister of Climate Change and Environment, has led a high-level delegation from the UAE to participate in ninth edition of Vibrant Gujarat Global Summit held in Gandhinagar on 18-20th January 2019. The Vibrant Gujarat Global Summit was inaugurated by Shri Narendra Modi, Hon'ble Prime Minister of India. The UAE participated in the event as a Partner Country for the second consecutive year.

The UAE delegation comprised of senior officials including H.E. Dr. Ahmed Al Banna, UAE Ambassador to India; Maj Gen (Retd.) Sharafuddin Sharaf, Chairman, UAE-India Business Council (UIBC) & Vice Chairman, Sharaf Group; Mr Jamal Majid Bin Theniyah, Chairman, Emaar India; Mr Yusuff Ali, Chairman and Managing Director, Lulu Group International; Mr Hadi Badri, Chief Strategy Officer, Emaar Properties; Mr Mohamed Juma Al Musharrkh, CEO, Sharjah FDI Office (Invest in Sharjah), and several other senior officials and business leaders from the UAE.

In his keynote address at the Summit's inauguration ceremony, H.E. Dr. Al Zeyoudi said, "The UAE and India enjoy long-standing and cordial relations across multiple fronts. Backed by the political and people-to-people interactions, bilateral trade continued to soar despite global headwinds. Valued at USD 180 million per annum in the 1970s, the balance of trade volume between India and the UAE is now worth USD 57 billion, making India the largest trading partner of the UAE, while the UAE is India's third largest trading partner – after China and the US. 2018 saw a flurry of investments by the UAE companies in India, and the UAE-India relationship has entered a vibrant growth phase with bilateral trade on track to exceed USD 100 billion by 2020."

His Excellency Dr. Al Zeyoudi noted that the UAE hosts the largest Indian expatriate community in the world, comprising more than 3.3 million people. Members of the Indian community in the UAE have helped the Indian economy flourish through their hard-earned remittances. The UAE is currently the largest source of remittances to India that amounted to an astounding USD 13.82 billion in 2017.









He added, "As we look back at our achievements, they energize us and give us the confidence that a lot more can be done together. We aspire to see the trajectory of the UAE-India ties continue to soar, entering new areas of cooperation and dynamism."

H.E. Dr. Thani bin Ahmed Al Zeyoudi had a meeting with Shri Narendra Modi, Indian Prime Minister on the sideline of the summit. The meeting addressed ways to enhance and strengthen economic and investment partnerships in areas of common interest, most notably infrastructure, energy, and tourism. Dr. Thani was accompanied by H.E. Dr. Ahmed Albanna, UAE Ambassador to India; Maj Gen (Retd.) Sharafuddin Sharaf, Chairman, UAE-India Business Council (UIBC) & Vice Chairman, Sharaf Group; Mr Jamal Majid Bin Theniyah, Chairman, Emaar India etc. for the meeting.

During the summit, H.E Dr. Al Zeyoudi had also met Shri Vijay Rupani, Hon'ble Chief Minister of Gujarat. In the meeting, both sides reviewed the entire gamut of bilateral ties and took stock of the developments in the region. Both Ministers while welcoming cooperation and the progress in the UAE-India bilateral relations, reaffirmed their determination to further strengthen the bilateral engagement.

At the Vibrant Gujarat Global Trade Show, held on the sideline of the summit, His Excellency Dr. Al Zeyoudi, accompanied by H.E. Dr. Ahmed Al Banna, inaugurated the UAE pavilion.

The UAE Minister also participated in the UAE Country Seminar where he highlighted the UAE's appeal as a global business destination.

Addressing UAE and Indian businesspeople at the event, he said, "The UAE has become a global hub for entrepreneurship and investment, thanks to the significant efforts made by the Federal Government and local departments to create a world class, business-friendly environment, enabling the country to vie with the best."

He added, "According to the World Bank's Doing Business Report 2019, the UAE moved up 10 spots to the 11th place globally, out of 190 economies. The report also states that the UAE is the best-performing country in the Middle East and North Africa region. The rise in the UAE's rank is a result of a package of reforms in the past year that boosted the country's economic competitiveness."

Elaborating on FDI, H.E. Dr. Al Zeyoudi said, "UAE investments in India are valued at an estimated USD 8 billion, of which USD 5.33 billion is in the form of foreign direct investment, while the remaining is portfolio investment, making UAE the 10th biggest investor in India in terms of foreign direct investment. The UAE's investments in India are concentrated mainly in six sectors: services, power, construction development, air transport, food, and hotels and tourism."

He added, "Several prominent private and public sector Indian companies and banks operate in the UAE. In addition, major Indian companies have been able to obtain a significant number of contracts in the UAE. Data released by the UAE Federal Competitiveness and Statistics Authority indicates that the total foreign direct investment from India to the UAE amounted to over USD 6.5 billion.

Participation of UAE Delegation in Partnership Summit



H.E. Sultan bin Saeed Al Mansoori, UAE Minister of Economy has led a high-level official delegation from the UAE to participate in the 25th edition of Partnership Summit 2019 held in Mumbai on 12-13th January 2019. The Partnership Summit witnessed the attendance of more than 1,400 participants from 40 countries around the world.

The Partnership Summit was inaugurated by Shri M. Venkaiah Naidu, Hon'ble Vice President of India and was addressed by Shri Suresh Prabhu, Hon'ble Minister of Commerce & Industry and Civil Aviation, Govt. of India; Shri Devendra Fadnavis, Hon'ble Chief Minister of Maharashtra, and several other key dignitaries. His Excellency Sultan Mansoori delivered the 'Special Address' in the Inaugural Session of the event.

The UAE was the Partner Country of the event and the high level delegation from the UAE included more than 40 senior officials and business leaders including H.E. Dr. Ahmed Al Banna, UAE Ambassador to India; H.E. Abdulla Al Saleh, Under-Secretary, UAE Ministry of Economy for Foreign Trade Affairs; H.E. Jamal Al Jarwan, Secretary-General, UAE International Investors Council (UAEIIC); H.E. Ahmed Mohammed Al Kaabi, Assistant Under-Secretary for Oil, Gas and Mineral Resources, UAE Ministry of Energy and Industry and the UAE Governor at OPEC; Mr Mohammed Hamdan Nasser Al Zaabi, Director - Trade Promotion, UAE Ministry of Economy; Mr Dawood Al Shezawi, CEO, Annual Investment Meeting (AIM), etc.







In order to showcase the investment opportunities in the UAE, a country seminar on 'UAE - Gateway for Business' was organised during the event. The seminar was addressed by key dignitaries including H.E. Dr. Ahmed Al Banna; H.E. Abdulla Al Saleh; H.E. Jamal Al Jarwan; H.E. Ahmed Al Kaabi; Mr Ahmad Alfalahi, Commercial Attache of UAE to India; Mr Essa Abdulla Al Ghurair, Chairman, Essa Al-Ghurair Investment L.L.C.; Mr Salah Sharaf, Executive Director, Sharaf Group, etc. The seminar highlighted the economic and trade cooperation between the two countries and discuss relevant opportunities to strengthen the economic and investment partnerships between their public and private sectors.

On the sideline of the event, His Excellency Sultan Mansoori had a bilateral meeting with Shri Suresh Prabhu and discussed areas of mutual cooperation and further enhancing bilateral trade & investments between both the countries.





Visit of Smt. Sushma Swaraj, Hon'ble Minister of External Affairs of India to the UAE





Smt. Sushma Swaraj was invited by H.H. Sheikh Abdullah bin Zayed Al Nahyan, UAE Cabinet Member and Minister of Foreign Affairs and International Cooperation as the 'Guest of Honour' to address the Inaugural Plenary of the 46th Session of the Council of Foreign Ministers of the Organisation of Islamic Cooperation (OIC) held on 1-2 March 2019 in Abu Dhabi.

In her plenary address, Smt. Sushma Swaraj observed that 2019 is a very special year since OIC is celebrating its Golden Jubilee, UAE is celebrating 2019 as the 'Year of Tolerance' and India is celebrating 150th birth anniversary of Mahatma Gandhi.

Smt. Sushma Swaraj conveyed her deep appreciation for the sagacious leadership of the UAE for inviting India for the OIC meeting and reiterated that the highly successful visits of H.H. Sheikh Mohammed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Deputy Supreme Commander of the UAE Armed Forces to India in 2017 as the Chief Guest on Republic Day and Prime Minister Shri Narendra Modi to Abu Dhabi in 2018 have cemented our ties bilaterally and with the region & beyond.

Indian External Affairs Minister underlined the steps taken by the Indian Government over the last five years or so to substantially enhance relations with individual member countries of OIC. Smt. Sushma Swaraj mentioned that more than USD 12 billion has been extended as lines of credit and nearly USD 4 billion as grant assistance to OIC member countries under our development partnership.

Hon'ble External Affairs Minister further added that India also offers around 4500 ITEC slots and 2000 educational scholarships annually to OIC countries contributing to their capacity building in a very big way. The trade between India and OIC countries was around USD 230 billion amounting to 30% of India's total trade.

The OIC meeting was also attended by H.E. Navdeep Singh Suri, Indian Ambassador to the UAE; Mr T. S. Tirumurti, Secretary (ER), Ministry of External Affairs, GoI; Dr. T.V. Nagendra Prasad, Joint Secretary (Gulf), Ministry of External Affairs, Government of India; Mr Vipul, Consul General of India in Dubai and other senior officials.





Visit of H.E. Dr. Sultan bin Ahmad Sultan Al Jaber, UAE Cabinet Member & Minister of State and Chief Executive Officer, ADNOC Group to India



H.E. Dr. Sultan bin Ahmad Sultan Al Jaber, UAE Cabinet Member & Minister of State and CEO, ADNOC Group visited India to participate in Petrotech 2019 held from 10 to 12th February 2019 in Delhi NCR. The 13th edition of Petrotech 2019, the international oil and gas conference and exhibition, was inaugurated by Shri Narendra Modi, Hon'ble Prime Minister of India in the august gathering of Ministers and delegates from around 60 participating countries.

The event was attended by Shri Yogi Aditya Nath, Hon'ble Chief Minister of Uttar Pradesh; Shri Dharmendra Pradhan, Hon'ble Minister of Petroleum & Natural Gas and Skill Development & Entrepreneurship, Gol; H.E. Dr. Ahmed Al Banna, UAE Ambassador to India; along with several other senior officials and business leaders.

In his inaugural address, PM Modi underlined the importance of energy as a key driver of socio-economic growth. PM said that last five years have seen major reforms in India's oil and gas sector. "India today has the fourth largest refining capacity in the world. This will further grow by about 200 million metric tons by 2030", he added.

He further added that currently, India is the fastest growing large economy in the world and could be the second largest global economy by 2030 and also the third largest energy consumer in the world. With energy demand expected to more than double by 2040 and India remains attractive market for energy companies, he added.

He noted that India is making rapid strides towards a gas based economy. Over sixteen thousand kilometres of gas pipeline has been constructed and an additional eleven thousand kilometers is under construction. The tenth bid round for City Gas Distribution cover over four hundred districts and extend coverage of City Gas Distribution to seventy percent of our population", he added.

Reminding the global community to join hands in tackling the challenge of climate change, he said targets we set for ourselves at COP-21 in Paris can be achieved. In this context, he mentioned that India has made rapid strides in meeting its commitments.









During the Petrotech energy conference, H.E. Dr. Sultan Ahmad Al Jaber was felicitated with the "International Lifetime Achievement Award" by Shri Narendra Modi for his unique contribution towards shaping the world's energy structure with his intellectual leadership, insight clear vision and practical guidance. The International Lifetime Achievement Award is reserved for exemplary work in the oil and gas industry at the global level.

While receiving the award, Dr. Al Jaber said, "I am honoured and humbled to accept an award that recognises ADNOC's evolution, under the wise guidance of the UAE's leadership, as an oil and gas company of the future that is responding to the expanding energy needs of the growth markets of Asia and, notably, India. Following the UAE Leadership's direction, ADNOC has built on the close bonds of friendship between the UAE and India to strengthen our strategic energy partnership".

Dr. Jaber shared, "In this new energy era, ADNOC is adopting more creative strategies and more flexible business models to capture growth, maximize efficiency and create greater value from every barrel of oil produced. There is a real need for the oil and gas industry to modernise, in order to ensure the world's growing energy needs are met in the 4th Industrial Age".

He further added that "At the same time, we are pushing the boundaries of partnership to bring technology, expertise and financial acumen, aimed at maximising the value of our resources, as we take advantage of the rising global demand for crude, refined and petrochemical products."

In his address, Shri Dharmendra Pradhan said, "Recognising the dramatic shift in energy demand among the rising economies of Asia and, in particular, India, Dr. Sultan Al Jaber has reshaped the buyer-seller relationship into one based on true strategic partnership. As a result, Dr. Sultan has made a valuable contribution to regional and global energy security, while redefining the traditional NOC business model to adapt to a fast-evolving energy landscape. In short, Dr. Sultan has proven himself a true industry pioneer, who is ensuring the oil and gas industry remains relevant, agile and responsive to the needs of the future."

While interacting with reporters on the sidelines of Petrotech 2019, Dr. Al Jaber acknowledged the close, mutually beneficial, strategic and economic relationship between the UAE and India. He mentioned that ADNOC is the only foreign oil and gas company, so far, to invest by way of crude oil in India's strategic petroleum reserves programme. It is also a stakeholder, along with Saudi Aramco, and a consortium of Indian state-run companies, in one of India's largest refinery and petrochemicals projects, to be constructed at Ratnagiri in Maharashtra. In addition, in February 2018, for the first time, an Indian consortium of three companies, comprising ONGC Videsh, Indian Oil Company and Bharat PetroResources Ltd., was awarded a 10% participating interest in Abu Dhabi's offshore Lower Zakum concession.

He shared that the UAE is keen on making more investments in India, both in refining and petrochemical projects, as well as stocking more crude in storage projects. "India is very high on our strategic agenda and expanding our strategic reserve in India will be an item on the agenda to be discussed with our friends and counterparts in India", he added.

"We are looking at the expanding investment portfolio in downstream sectors, especially in oil refining and petrochemicals. We are only looking at strategic partnerships given that we can also bring our own crude. India is not only an important market for us, India is a very strategic partner. We will continue to always look for ways to enhance our avenues of cooperation," Dr. Al Jaber said.

Visit of H.E. Mariam Bint Mohammed Saeed Hareb Al Mehairi, UAE Minister of State for Food Security





H.E. Mariam Bint Mohammed Saeed Hareb Al Mehairi, UAE Cabinet Member and Minister of State for Food Security had visited India on 27-28th March 2019 to discuss bilateral cooperation between UAE and India in areas of food security.

During her visit, H.E. Mariam Al Mehairi had met Shri Suresh Prabhu, Hon'ble Minister for Commerce & Industry and Civil Aviation, Gol. In the meeting, both dignitaries discussed about setting up of a 'Food Security Alliance' and further strengthening the bilateral relations between both the countries. The discussion was centred on establishing a dependable long term partnership of India with the UAE for its food security through knowledge sharing, cooperation for R&D in agricultural technology, farming, reducing food wastage, customizing & standardizing the agro food products as per UAE standards, etc.

In her another meeting with Ms Pushpa Subrahmanyam, Secretary, Ministry of Food Processing, Govt. of India, H.E. Mariam Al Mehairi discussed about UAE-India bilateral cooperation in areas of Food Security including reduction of the wastage of the perishable agri produce, enhancing shelf life of food products, etc.

H.E. Mariam Al Mehairi had also met Dr. Awasthi, Managing Director & CEO, Indian Farmers Fertiliser Cooperative Limited (IFFCO). During the meeting, both sides held strategic discussions regarding long term association for sustainable Food Security and ways & means of collaboration with IFFCO for food security requirements.

H.E. Dr. Ahmed Albanna, UAE Ambassador to India accompanied Her Excellency for the above meetings.

During the visit, H.E. Mariam Al Mehairi visited Indian Agricultural Research Institute (IARI) and met senior officials to discuss various avenues for enhancing bilateral cooperation in the areas of agriculture between the UAE and India. H.E. Mariam Al Mehairi also visited industrial plants of LT Foods and Kohinoor in Haryana and discussed with their management regarding expanding their businesses in the MENA region through UAE. Her Excellency was accompanied by H.E. Dr. Ahmed Albanna, UAE Ambassador to India and Mr Ahmad Alfalahi, Commercial Attache of the UAE to India.

H.E. Mariam Al Mehairi also participated in an interactive session with the agro and food processing industry players including Lulu Group, Advoc, Dabur, Mother Dairy, LT Foods, Kohinoor Foods, etc. While addressing the participants, H.E. Mariam shared that the prospects for productive engagement between the UAE and India in this sector are immense. She said that concept of a bilateral Food Security Alliance is similar to strategic cooperation between the UAE and India in Energy Security, which was conceptualized following the recent high level exchanges by leaders of both countries.

In the meeting, H.E. Mariam unveiled the idea of setting up an "Indian Food City" in the UAE. She said, it could be set up in a free zone in the UAE and would work well for value addition in the zone and exports to third countries. Her Excellency further added that such a facility would allow India to bring its advanced food and agricultural technology which can be harnessed in the UAE for mutual benefit.

Visit of Shri Pinarayi Vijayan, Hon'ble Chief Minister of Kerala to the UAE





A high level delegation led by Shri Pinarayi Vijayan, Hon'ble Chief Minister of Kerala had visited UAE from 13 to 16th February 2019 to attract investments in the State. Hon'ble Minister was accompanied by Mr Tom Jose, Chief Secretary of Kerala; Dr. Kamala Kannan Ellangovan, Principal Secretary (Industries), and other senior officials from the State Government.

He presented specific investment projects including an Aerospace Park near Kannur Airport, Petrochemical Park, Food Procurement Park, Spices Park, Defence Park and a Life Sciences Park for ADIA's consideration. He also extended an invite to H.H. Sheikh Hamed to visit Kerala.

In his another meeting with H.E. Dr. Sultan Bin Ahmad Al Jaber, UAE Cabinet Member and Minister of State and CEO, ADNOC Group, Shri Pinarayi Vijayan invited ADNOC to invest in a proposed 380-acre petrochemical complex in Kochi in Kerala. Visit of H.E. Hussain Bin Ibrahim Al Hammadi, UAE Minister of Education to India





January 2019: H.E. Hussain Bin Ibrahim Al Hammadi, UAE Minister of Education, along with delegation from the UAE, had visited New Delhi on an official visit to learn about India's experience in the field of education and human resource development.

During the visit, H.E. Hussain Hammadi had met Shri Prakash Javadekar, Hon'ble Minister of Human Resource Development, Government of India and discussed on enhancing cooperation in the field of education and to strengthen the relationship between the UAE and India. H.E. Hammadi was accompanied by H.E. Dr. Ahmed AlBanna, UAE Ambassador to India and other UAE delegation members for the meeting.

H.E. Hammadi thanked the Indian Government for the invitation and shared that India's experience in education is one of the most successful experiences at the regional and international levels. There is a consensus among industry experts that this experience is the key to India's successes and achievements in science, technology, space and scientific education including medical and engineering, which offers a modern educational level comparable to that of developed countries.

While highlighting the areas of cooperation in educational sector, H.E. Hammadi shared that the India's rich experience in the education sector can be used to improve the quality of education in the UAE especially for promoting creativity and development of innovative skills.

His Excellency further added that UAE can work with India to customize a grading system for ranking UAE institutions, open platform of education (online education) which will not only benefit students of UAE but the entire Middle East and Africa region specially those Arab states which are going through disrupt political phase and student exchange programs as well.









Shri Prakash Javadekar welcomed the suggestions of H.E. Hussain Bin Ibrahim Al Hammadi and expressed mutual concern on them. He also appreciated the UAE for its pilot program to issue teaching license for all of the teachers employed in the country which will get renewed every 5 years for which they would need to undergo an exam. Hon'ble HRD Minister of India further suggested for organising meetings of senior officials from both the sides to identify the areas of cooperation and signing of MoUs to work together in the field of education and HRD.

H.E. Hammadi and his accompanied delegation had also met with the officials of Educational Consultants India Limited (EdCil), a Public Sector Enterprises under the Ministry of Human Resource Development, offering management and consultancy services for development of new educational methods.

Through more than around 25 different events/ activities, the Sharjah Pavilion brought the cultural vision of Sharjah that lays special emphasis on bringing nations and cultures together through vibrant interactions and exchange of books and knowledge.

The seventh edition of CEO Speak was held on the sideline of NDWBF. The "India–Emirati Forum" organised at the event offered publishers a common platform to explore emerging business opportunities and discuss shared challenges and how to face them. While addressing the participants at India-Emirati Forum, Mr Ahmed bin Rakkad Al Ameri, Chairman, Sharjah Book Authority, said that "the participation in the New Delhi World Book Fair will increase the understanding of Arab and Emirati culture in India through literary exchange besides bridging cultural communication between both countries."

The Emirates Publishers Association organised a panel discussion titled "UAE's Experience in the Publishing Field", at the book fair. It addressed the unique capabilities of the UAE's publishing industry, many opportunities offered by the local market, and shed light on the government's efforts to promote industry practices. It was moderated by Mr Rashid Al Kous, Executive Director, Emirates Publishers Association, who emphasised that the selection of Sharjah as the UNESCO World Book Capital 2019 is an ideal opportunity to introduce Indian publishers to the investment opportunities in the UAE's book market and enable them to boost collaboration with local publishers.

Sharjah has also hosted a historical symposium shedding light on India's prominent position in the cultural legacy of Arabic books and manuscripts. An intellectual discussion titled 'India in the Arabic Manuscripts' was attended by several Arabic writers, poets and historians. The session emphasized on exploring ways to bring unpublished manuscripts written in the era that detail Indo-Arab relations to the attention of publishers, so more can be learnt about the historical exchanges between the two cultures, and the importance of disseminating the information contained within these manuscripts was highlighted.

Special Olympics World Games Abu Dhabi 2019





The Special Olympics World Games 2019 was hosted in Abu Dhabi, UAE from 14 to 21st March 2019 for the first time in the Middle East and North Africa since the movement's founding over 50 years ago. The event was held under the Patronage of H.H. Sheikh Mohammed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Deputy Supreme Commander of the UAE Armed Forces with a mission to promote positive social change for people with intellectual disabilities and create a more inclusive society.

With more than 7,500 athletes and 3,000 coaches, representing over 192 nations for seven days of incredible Olympic-style sports, the Special Olympics World Games at Abu Dhabi 2019 was the largest sports and humanitarian event in the world and set the benchmark for the most unified Games in the 50-year history of the Special Olympics movement. It aimed to empower people with intellectual disabilities to become accepted and valued members of their communities, which leads to a more respectful and inclusive society for all. The event saw the participation of thousands of spectators including Government and business leaders, celebrities and activists, Honored Guests and more.

In addition to sports competition, the 2019 World Games featured inspiring non-sports activities and programs, including Unified Sports experiences, free Healthy Athletes screenings, a GenUin Global Youth Summit, and the Law Enforcement Torch Run.

The World Games was officially opened by H.H. Sheikh Mohamed bin Zayed Al Nahyan, Crown Prince of Abu Dhabi and Deputy Supreme Commander of the UAE Armed Forces. In his inaugural speech, H.H. Sheikh Mohamed bin Zayed Al Nahyan stated that he feels proud to be with the Special Olympics athletes and said them, "Here in the UAE, everyone supports you and takes pride in you." He further added that the UAE would be able to deliver a message to the world that anything can be possible if the person has determination.

India participated in the Special Olympics World Games for the 9th time and created history by clinching an astounding tally of 368 medals, including 85 gold, 154 silver and 129 bronze at the Special Olympics World Summer Games Abu Dhabi 2019.

284 athletes from India participated in the prestigious event and medals were won across all sports including athletics, golf, volleyball, aquatics, cycling, judo, powerlifting, table tennis, roller skating, badminton, basketball traditional, handball traditional and football 7-side female at the Special Olympics 2019.

Indian powerlifters performed brilliantly and bagged the maximum number of medals including 20 gold, 33 silver and 43 bronze while Roller Skating team earned India 49 medals including 13 gold, 20 silver and 16 bronze. In cycling, the Indians won 11 gold, 14 silver and 20 bronze to total 45 medals, while the country's track and field athletes returned with 39 medals including 5 gold, 24 silver and 10 bronze. It was also the first time India participated in Judo and Futsal, clinching 3 gold, 1 silver and 7 medals respectively. This was by far the best performance by Indian Team at the Special Olympics World Games.

ADNOC awards Onshore Exploration Block to Indian Consortium





March 2019: Urja Bharat Pte Ltd, a 50:50 consortium of Indian Oil Corporation Ltd (Indian Oil) and Bharat PetroResources Ltd (BPRL), has won the entire stake in the Abu Dhabi onshore Block 1 concession. BPRL is a subsidiary of Bharat Petroleum Corporation Ltd (BPCL). The award has been endorsed by Abu Dhabi's Supreme Petroleum Council (SPC) and represents a further deepening of the fast-growing UAE-India energy relationship.

Under the 35-year Agreements, the Indian consortium will hold a 100% stake in the exploration phase and invest up to AED 626 million (USD 170 million), including a participation fee, to explore for and evaluate oil and gas opportunities in the block, which covers a large area around Ruwais and includes already discovered but undeveloped conventional oil and gas fields.

Following successful exploration activities and appraisal of the existing discoveries, the Indian consortium will be granted the opportunity to develop and produce any discoveries. The Agreement includes an option for ADNOC to hold a 60% stake in the production phase. The Agreements were signed by H.E. Dr. Sultan Ahmed Al Jaber, UAE Minister of State and CEO, ADNOC Group; Mr D. Rajkumar, Chairman and Managing Director, Bharat Petroleum Corporation Ltd; and Mr Sanjiv Singh, Chairman, Indian Oil Corporation.

During the signing ceremony, H.E. Dr. Al Jaber said, "This award highlights the important role of energy cooperation in strengthening the strategic relationship between the UAE and India. It also underlines ADNOC's 2030 smart growth strategy and our targeted approach to engage with value-add partners who can contribute the right combination of market-access, capital and technology, as we reinforce our position as an essential energy provider to the world."

He further added that "The consortium of Bharat Petroleum Corporation and Indian Oil Corporation, both of whom ADNOC already partners with offshore, was selected after a very competitive bid round. The open bidding process represents a major advance in how ADNOC is accelerating the exploration and development of Abu Dhabi's substantial untapped hydrocarbon resources as we continue to maximize value, in line with the UAE leadership's directives."

Mr D. Rajkumar said, "We are elated with the award of Onshore Block 1, which strengthens our historical engagement with ADNOC and the UAE, giving further impetus to the already flourishing relationship in the energy sector between ADNOC and India's leading Oil and Gas Fortune 500 companies, Bharat Petroleum Corporation and Indian Oil Corporation."

Mr Sanjiv Singh said that "We are delighted to be chosen by ADNOC to participate in this project, which will strengthen our efforts to achieve India's energy security. It is the second time that Indian oil and gas companies would venture into the development of hydrocarbon resources in the UAE, after acquiring stakes in Abu Dhabi's Lower Zakum Concession. We look forward to further strengthening our relationship in the hydrocarbons sector of the UAE."

In the past 12 months, ADNOC has enhanced its strategic energy links with India, a key growth market for crude, refined and petrochemical products. It is the only foreign energy company, so far, to partner in India's strategic petroleum reserves program. It is also a stakeholder in one of India's largest refinery and petrochemicals projects, to be constructed on India's west coast. In addition, in February 2018, for the first time, an Indian consortium of three companies, comprising ONGC Videsh, Indian Oil Company and Bharat PetroResources Ltd., a subsidiary of Bharat Petroleum Corporation, was awarded a 10% participating interest in Abu Dhabi's offshore Lower Zakum Concession.


To work in the UAE, Indian nationals have to obtain an equivalency certificate from the UAE Ministry of Education for their educational and professional qualifications. Many such applications for equivalency from Indians have been rejected in the past due to lack of clarity over internal or external marks in their mark lists.

Following the Indian Ambassador's meeting with the UAE Education Minister, the UAE Ministry of Education conveyed that it has reviewed the information provided to it through the 'Action Plan for Academic and Administrative Reforms' issued by the India's University Grant Commission (UGC). The UAE Education Ministry has come to know that the word "external" in the mark sheet reflects the method of evaluation and not place of study and notified that it has no objection to equivalence those degrees that meets all other certificate equivalency criteria.

The UAE Ministry also notified that those applications that have been rejected previously will be reviewed and equivalency letters would be issued after meeting all other certificate equivalency conditions.

The UAE Ministry of Education further informed that it is working on all such applications gradually and requested for cooperation from all concerned as it will take some time to review all these cases due to vast number of such applications.


